#### **Patient Care**

**Goal:** TidalHealth General Surgery residents must be able to provide patient care that is compassionate, appropriate, and effective for the treatment of health problems and the promotion of health.

**Objective:** To meet the objectives of this rotation, residents should be introduced to:

- 1. Advanced laparoscopic surgery (ex: Inguinal, Ventral Hernias, Gastric bypass/banding, Nissen, paraoesophageal hernia repair)
- 2. Complex open general surgical procedures including trauma laparotomies, hepatobiliary procedures, bariatric procedures, and endocrine procedures.
- 3. Resident is expected to be proficient at:
  - a. Right and left colectomy, small bowel resection
  - b. Supervision of complete pre and postoperative care
  - c. Inguinal, ventral and umbilical hernia repairs
  - d. Evaluation and operative management of benign and malignant breast masses
  - e. Laparoscopic and open cholecystectomies
  - f. General bariatric procedures including open and laparoscopic procedures.
- 4. Demonstrate clearly improved operative skills throughout the rotation, with a focus on pre-operative planning, operative exposure, operative decision making, and excellent technical skills.
- 5. Perform as the operating surgeon for major cases and as a teaching assistant to junior residents for minor cases.
- 6. The PGY-5 is responsible for overseeing postoperative care for all patients on the inpatient service.
- 7. The PGY-5 is responsible for guiding the preoperative assessment and workup of all patients with general surgery needs.
- 8. The PGY-5 should evaluate all consults and determine whether operative care or medical care is necessary for their team.
- 9. The PGY-5 should demonstrate the ability to manage and run a complex general surgical team.

  - b. Evaluating acute medical and surgical conditions including myocardial infarction, hemorrhagic shock, and respiratory distress
- 3. Resident is expected to be proficient at:
  - a. Anticoagulation in vascular surgery patients
  - b. Management of femoral artery sheaths

  - a. Damage control surgery
  - b. FAST exam
  - c. Cricothyroidotomy
  - d. Emergent thoracotomy
  - e. Exploratory laparotomy for trauma
- Demonstrate the comprehensive ability to evaluate and manage medical conditions in various systems including injuries in the liver, pancreas, gastrointestinal tract, respiratory and cardiovascular systems, and spleen.
- 3. Demonstrate the advanced ability to formulate and institute therapeutic plans.
- 4. Demonstrate the advanced ability to utilize treatment algorithms and rapid evaluation strategies for trauma patients with multiple injuries.
- 5. Demonstrate the ability to actively apply intra-operative techniques to properly assess multiple injuries.
- 6. Demonstrate the comprehensive ability to order, interpret, and evaluate laboratory studies and tests used on the trauma service, including but not limited to:
  - a. CT scans
  - b. Urinalysis
  - c. Coagulation studies
  - d. Intracranial pressure monitoring
  - e. Complete blood count
- 7. Demonstrate the ability to supervise and educate medical students and junior residents on the trauma service.

## **Medical Knowledge**

**Goal:** TidalHealth General Surgery residents must demonstrate knowledge of established and evolving biomedical, clinical, epidemiological, and social-behavioral sciences, as well as the application of this knowledge to patient care.

**Objective:** To meet the objectives of this rotation, residents should be able to:

1. Demonstrate comprehensive knowledge of the indications, contradictions, risks, and benefits of various antibiotics and medications commonly used on the trauma service.



- 2. Demonstrate a comprehensive understanding of the mechanisms and types of airway injuries and identify their signs, symptoms, and management.
- 3. Demonstrate knowledge of the management of trauma situations and emergencies and role model these skills for junior residents, including but not limited to:
  - a. Liver failure
  - b. Nutritional failure
  - c. Renal failure
  - d. Hypovolemic shock
  - e. Life threatening surgical infections
  - f. Multiple organ system failure
- 4. Demonstrate a comprehensive understanding of the various types of internal and external fixation devices and their applications in multiple trauma injury situations.
- 5. Demonstrate a comprehensive understanding of the treatment protocols for severe soft tissue injuries including but not limited to compartment syndrome and organ failures in polytrauma.

### **Professionalism**

**Goal:** TidalHealth General Surgery residents must demonstrate a commitment to professionalism and an adherence to ethical principles.

**Objective:** To meet the objectives of this rotation, residents should be able to:

- 1. Proficiently demonstrate sensitivity and responsiveness to a diverse patient population, including diversity in age, gender, culture, race, religion, sexual orientation, and disabilities.
- 2. Demonstrate respect for patient privacy and autonomy.
- 3. Demonstrate a commitment to one's patients superseding personal self-interests, including providing bedside patient care and operative care to the patient.
- 4. Proficiently carry out administrative responsibilities.
- 5. Demonstrate the proficient ability to apply time management principles to be accountable to patients and other health care professionals.

## **Practice-Based Learning and Improvement**

**Goal:** TidalHealth General Surgery residents must demonstrate the ability to investigate and evaluate their care of patients, to appraise and assimilate scientific evidence, and to continuously improve patient care based on constant self-evaluation and lifelong learning.

**Objective:** To meet the objectives of this rotation, residents should be able to:

1. Demonstrate the proficient ability to utilize journal articles and available information technology to master surgical principles.



- 2. Demonstrate mastery in educating patients, families, medical students, and junior residents during the rotation.
- 3. Proficiently incorporate formative evaluation feedback into daily practice.
- 4. Demonstrate mastery in identifying teachable moments and be able to respectfully engage the learner.
- 5. Demonstrate the skills to identify trends and patterns in patient care and use sources to understand these patterns.

## **Interpersonal and Communication Skills**

**Goal:** TidalHealth General Surgery residents must demonstrate interpersonal and communication skills that result in the effective exchange of information and collaboration with patients, their families, and other health professionals.

**Objective:** To meet the objectives of this rotation, residents should be able to:

- 2. Demonstrate competency in developing and maintaining therapeutic relationships with patients by using effective listening skills and feedback.
- 3. Demonstrate mastery in gathering and documenting patient information accurately and completely.
- 4. Demonstrate the ability to always manage the patient's confidential information and medical records according to HIPAA standards.
- 5. Proficiently answer the patient's and their family's questions and demonstrate effective behaviors when communicating bad news.

#### **Systems-Based Practice**

**Goal:** TidalHealth General Surgery residents must demonstrate an awareness of and responsiveness to the larger context and system of health care, including the social determinants of health, as well as the ability to call effectively on other resources to provide optimal health care.

**Objective:** To meet the objectives of this rotation, residents should be able to:

- 1. Demonstrate mastery when applying cost-effective care when ordering tests and planning interventions.
- 2. Proficiently recognize when other specialists and health care professionals are needed to optimize the efficiency of care.
- 3. Actively participate in groups or teams designed to reduce errors and improve health outcomes.
- 4. Proficiently understand the different health insurance plans and how each may affect the treatment plan for patients.
